 While registering with One2One Risk Solutions, you will have the option to purchase an annual damage waiver that will protect you from the cost to repair or replace your District-issued device, subject to a small per-occurrence deductible, should a loss occur.



- o This coverage is similar to what is offered when purchasing personal electronics.
- The annual cost of the damage waiver is \$20 for each student but will be reduced by \$5 for each additional family member receiving a device in the district.
- You may make payments using a credit/debit card, online check, or cash using a pre-paid card available for purchase at the pre-paid card station during registration.
- You may purchase the damage waiver online beginning July 15th by visiting "www.one2onerisk.com".
